	SUPREP PREPARATION FOR A COLONOSCOPY
	Il need the following supplies for a successful colon preparation: Pick up the prep medications that were sent into the pharmacy within the next 3 to 4 days.
The day	before your colonoscopy (Prep Day):
	You are to have CLEAR LIQUIDS ONLY THE ENTIRE DAY OF PREPARATION. Examples: Water, Jell-O, iced popsicles, Italian Ice, Gatorade, Powerade, or sodas that are not red or orange in color, apple juice, white cranberry or white grape juice, iced tea, black coffee or hot tea, chicken or beef broth/bouillon. Avoid solid foods, milk or dairy products, alcohol, anything with red or orange dyes. Please drink as much as comfortably possible so that you do not get dehydrated and your colon will be properly flushed. At 5:00 P.M.: DO NOT follow instructions on prep kit. Step 1 - Pour One (1) 6-ounce bottle of SUPREP liquid into the mixing container that is provided in the kit. Step 2 - Add cool drinking water or lemon lime Gatorade to the 16-ounce line on the container and mix. Step 3 - Drink ALL the liquid in the container. Step 4 - You must drink two (2) more 16-ounce containers of water or lemon lime Gatorade over the next 1 hour.
	Remainder of the evening continue clear liquids.
DAY OF THE PROCEDURE	
6 HOURS PRIOR TO YOUR ARRIVAL TIME Repeat Steps 1 – 4.	
	YOU MAY DRINK CLEAR LIQUIDS UP UNTIL 4 HOURS PRIOR TO YOUR ARRIVAL TIME THE DAY OF YOUR PROCEDURE. No lozenges, hard candy or chewing gum. No smoking after midnight.
	YOU MUST HAVE A RESPONSIBLE ADULT TO DRIVE YOU HOME AFTER YOUR PROCEDURE IS COMPLETED. YOU MAY NOT WALK, RIDE A BUS, TAKE A TAXI OR ANY OTHER FORM OF PUBLIC TRANSPORTATION. You are considered under the influence of narcotics and CANNOT DRIVE or WORK for the remainder of the day.
